JOINT STIPULATION OF DISMISSAL

WHEREAS, Rule 41(a)(1)(ii) provides that a plaintiff may dismiss an action without a court order by filing a stipulation of dismissal signed by all parties who have appeared; and

WHEREAS, Plaintiff Northwestern University and Defendants Mitsubishi Electric Corp. and Mitsubishi Electric Automation, Inc. (together, “Defendants”) have agreed to settle Plaintiff’s claims for relief against Defendants, and Defendants’ counterclaims against Plaintiff, asserted in the *Northwestern University v. Mitsubishi Electric Corp.*, et al., Case No. 1:21-cv-0607 action (“the action”); and

WHEREAS, under the agreement, Plaintiff and Defendants agreed that, in exchange for certain consideration, Plaintiff and Defendants shall dismiss the claims against one another in the action with prejudice and that each party shall pay its own attorneys’ fees, costs of suit, and other expenses;

NOW, THEREFORE, Plaintiff and Defendants have signed this Joint Stipulation of Dismissal and stipulate to the dismissal of the action with prejudice, except as necessary to effectuate enforcement of the agreement.
