Amici are former Chief Justices and Justices of the Supreme Court of Delaware, as well as Chancellors and Vice Chancellors of the Delaware Court of Chancery, all of whom have a continuing interest in, and substantial experience with, the interpretation of Delaware's corporate law.¹

The Former Delaware Chief Justices, Justices, Chancellors, and Vice Chancellors concur with the interpretations of Delaware law expressed in the Brief of *Amici Curiae* Professors Joseph A. Grundfest and Mohsen Manesh in Support of Defendants-Appellees in this proceeding, including, in particular, that: (1) the remedies available in this derivative action are

duplicative of the remedies available in Delaware derivative actions; (2) the federal derivative claim at issue in this litigation is contingent on Delaware law both for its existence and for the definition of its critical metes and bounds; (3) where a stockholder claims that a false or misleading disclosure impaired the stockholder's right to cast an informed vote, that claim is direct, not derivative; (4) Delaware General Corporate Law Section 115 is irrelevant to the validity of the forum selection provision at issue in this litigation; and (5) the forum selection provision at issue in this litigation is enforceable under Delaware law.
