1 Plaintiffs file this Notice of Supplemental Authority to bring to the  
 2 Court's attention the attached Order Concluding That Service Has Been  
 3 Achieved, dated December 20, 2022, in *CFTC v. Ooki DAO*, N.D. Cal. No.  
 4 22-cv-5416-WHO. *See* Attachment; *see also, e.g., Victorino v. FCA US*  
 5 *LLC*, 326 F.R.D. 282, 305 n.14 (S.D. Cal. 2018) (considering supplemental  
 6 authority where it was "relevant to the analysis in th[e] case").

7 On October 6, 2022, after that action was filed, this Court issued an  
 8 order stating that it "will take the CFTC's recent actions into account to  
 9 the extent they are legally relevant." ECF No. 44 at 2:10–11. The  
 10 attached order in that case updates this Court on the most recent  
 11 developments there, including the fact that the Northern District of  
 12 California "conclude[d] that the CFTC sufficiently alleged, for the  
 13 purposes of their service motion, that Ooki DAO is an unincorporated  
 14 association under state law." *See* Attached Order at 10:11–12.
